2. Stipulations of the Account Holder

The Bank shall provide online banking services under the stipulations of this Agreement and the Bank's General Terms and Conditions and the Act V of 2013 on the Civil Code of Hungary and the Act CCXXXVII of 2013 on Credit Institutions and Financial Enterprises. The online banking services under this Agreement shall be available to individuals designated in Annex "A".

3. Consumer Protection

- The Account Holder shall pay considerations for banking services.
- The Parties declare that prior to conclusion of the agreement the Bank explicitly brought those provisions of the Bank's General Terms and Conditions, as well as the List of Terms and Service Prices and the Announcements to Account Holder's attention that relate to the Agreement and differ from regular contractual practice or are not strictly connected with the subject of the Agreement. The Account Holder specifically and explicitly declares that they had the opportunity to study these clauses

prior to conclusion of the Agreement. The Account Holder accepts that the Bank's General Terms and Conditions, as well as the List of Terms and Service Prices and the Announcements constitute inseparable parts of the Agreement and declares furthermore that they have learnt the provisions of the same and accept them as binding. By signing the Agreement, the Account Holder explicitly authorises the Bank to manage, forward and process their data in line with the provisions of the Bank's General Terms and Conditions.

- The Parties agree that the Bank shall have the right to unilaterally modify its General Terms and Conditions, as well as the List of Conditions and the Announcements at any time, according to Section 3 of the General Terms and Conditions.
- The Parties shall make their legal statements by mail, to the notification address shown in the header of this Agreement. The Parties shall notify each other of any change occurring in their notification addresses.

The Parties have read and uniformly interpreted this Agreement, and sign it hereunder as fully in line with their intention.
