- the overnight rates (€STR, SOFR, SONIA, TONAR, or SONAR) applied on the end-of-day balance for any day are those published for that day.
- The 1-month EURIBOR rate, which will be used in the end-of-day balance each day will be the rate as published two TARGET days before such date.
- interest payable is calculated quarterly in arrears on the last day of each calendar quarter (such day excluded and the last day of the preceding calendar quarter included).

## Currencies

Payment Instructions can be executed in any major currency.

## Exchange rates

The Bank executes payment transactions where a currency conversion is required by using the Euro foreign exchange reference rates published by the European Central Bank on the day of execution. For actual exchange rates you may contact the Bank. A margin between 0.06% and 1.94% depending on the currency is added for amounts < €50,000. The exchange rate is negotiated on the exchange market for amounts > or = to €50,000. Buying and selling of foreign currencies (spot/forward): not subject to tax.
